**INFORMATION**

The State of Nevada, by and through legal counsel, AARON D. FORD, Nevada Attorney General, and STEVEN SIDHU, Senior Deputy Attorney General, informs this Honorable Court that BROTHERS BEHAVIORAL HEALTH, LLC, the Defendant above named, has committed the offense of **SUBMITTING FALSE MEDICAID CLAIMS**, a category D felony violation of NRS 422.540(1)(a) and NRS 422.540(2)(a) [NOC 56141], one (1) count, as follows:

**COUNT I**  
**SUBMITTING FALSE CLAIMS: MEDICAID FRAUD**  
**[NRS 422.540(1)(a) and NRS 422.540(2)(a) Felony, Category D]**

Defendant BROTHERS BEHAVIORAL HEALTH, LLC (“BROTHERS”), through a scheme or continuous course of conduct, with intent to defraud, knowingly and intentionally made false claims or caused false claims to be made for payment from

1 Medicaid, in an aggregate amount greater than or equal to \$650:

2 From in or about January 2021 through in or about September 2022, in Clark  
3 County, Nevada, Defendant BROTHERS, by and through, Isai Anaya-Estrada (“Anaya-  
4 Estrada), submitted claims to Medicaid asserting that specific services were provided to  
5 the Medicaid recipients by healthcare professionals employed by BROTHERS and  
6 requested reimbursement for provision of services. Defendant knew that such services  
7 were not actually provided because the recipients were deceased. The Medicaid recipients  
8 did not receive the specific services from BROTHERS that Defendant claimed were  
9 delivered to the Medicaid recipients.

10 Defendant BROTHERS did in fact make false claims to Medicaid, resulting in  
11 payment from Medicaid in an amount greater than or equal to \$650.

12 All of which was committed in Clark County, aggregating in an amount greater than  
13 or equal to \$650.00, and constitutes a category D felony in violation of NRS 422.540.

14 All of which is contrary to form, force and effect of the statutes in such cases made  
15 and provided and against the peace and dignity of the State of Nevada. Furthermore,  
16 complainant makes this declaration subject to the penalty of perjury.
